Outcome: Interim conditions continued

- 1. You must carry out all consultations conducted in private with female patients – namely those intended not to be observed or overheard by others – and all examinations or assessments of female patients, other than purely visual examinations or assessments of female patients in public, in the presence of another pharmacist or pharmacy technician registered with the GPhC, or another registered healthcare professional, except in life-threatening emergencies. For the avoidance of doubt, this condition extends to the administration of vaccines in the course of the Registrant's pharmacy business and at vaccination clinics. If a patient does not want to have the chaperone present you should not proceed. This condition applies equally to*

any consultations or examinations of female patients carried out using video-technology.

2. *You must keep a written record, made immediately afterwards, of all consultations and examinations that have involved a chaperone as required by condition 1 above. This must have clear entries of the name, qualification and professional registration number of the chaperone and each entry must be signed and dated by you and the chaperone. You must send this to the GPhC every month, or when we ask for it, and at any review.*
3. *You must:*
 - *tell the GPhC before you take on any new role or position for which you must be registered with the GPhC, which includes being commissioned or contracted to provide pharmacy services, and*
 - *give the GPhC details of the role, and*
 - *give the GPhC the contact details of any employer, superintendent pharmacist to whom you become answerable and owner of any pharmacy for whom you contract to work.*
4. *You must tell the following people in writing about the restrictions imposed on your pharmacy practice, if you undertake any paid or unpaid work for which you must be registered with the GPhC.):*
 - *All employers or contractors, or persons or organisations which seek to commission pharmacy services from you or the companies you own or control*
 - *Agents acting on behalf of employers and locum agencies*
 - *Superintendent Pharmacists*
 - *Responsible Pharmacists*
 - *Line Managers*

- *And for each chaperone who accompanies the Registrant at consultations in private or any examination in private of female patients, such notice may be given either orally or in writing.*
5. *You must send the GPhC a copy of any notifications required by Condition 4 above. If you are applying for work, you must tell any prospective employer about the restrictions imposed on your pharmacy practice when you apply. If you or your companies are commissioned or contracted with to provide pharmacy services you must inform the commissioning or contracting entity of these conditions in advance of providing such services.*
 6. *You must tell the GPhC if you apply for work as a pharmacist or pharmacy technician outside Great Britain*
